**MEMBERSHIP DECLARATION** Waterloo Tennis Club is WTC

- 2 **Bound by Rules:** I will be bound by the constitutions, regulations, policies, manuals, guidelines and reasonable directions of the WTC.
- 3 **Accept Risk of Tennis:** I have voluntarily accepted and assumed the inherent risk of danger and injury in tennis.
- 4 **No liability:** I will not hold the WTC, or their respective officers responsible or any claims, losses and expenses and costs (including legal costs) which may arise from or in connection with my membership and/or participation in any activity authorised or recognised by the WTC, except in the case of gross negligence or a wilful act or omission on the part of the WTC.
- 5 **Indemnity:** I indemnify the WTC, from all claims, losses and expenses (including legal costs) suffered or incurred at any time as a result of, or resulting directly or indirectly from, my failure to observe the constitutions, regulations, policies, manuals, guidelines and reasonable directions of the WTC
- 6 **Medical Declaration:** I am medically and physically fit and do not suffer from any injury, disease or condition, either physical or mental, that would affect my ability to safely participate in any authorised or recognised activities of the WTC. If I am unsure about this declaration, or suffer from such a condition I have either listed it on the application for membership form or I am aware that I must bring it to the attention of the WTC.
- 7 **Privacy:** I agree that the WTC can collect, hold, use and disclose my personal information on the Application for Membership Form (and any updated or additional personal information the WTC obtains from me whilst a member including any photo or other record of my image) for the purposes of:
  - a. Processing my application for membership including notifying OTA of the information on the Application for Membership Form for the purposes of the WTC compiling a register of members;
  - b. If I agree, putting my name and contact information on the WTC membership list for use by other members of the WTC;
  - c. Publishing any of my tennis results in the WTC, the OTA and on their websites;
  - d. Selecting and naming publicly players, officials and teams to represent the WTC, the OTA at tennis events;
  - e. If I agree providing me with information and activities relating to the WTC, the OTA and other tennis matters;
  - f. If I agree enabling sponsors and funders of the WTC, to contact me with information about their product and services.
  - g. Any other purpose I agree to in writing.
- 8 **Use, Security and Access:** I understand that my personal information will only be used for the purposes listed in paragraph 7 and that:
  - a. My personal information will be held securely.

  - c. My personal information will be corrected upon request.
